**In the event that no moorage is available you may choose to be added to our wait list, subject to the following terms and conditions:**

- 1) A nonrefundable deposit of \$50.00 is required to secure a place on the waitlist. This deposit will be applied to the first month's moorage, upon acceptance of a moorage offer and after delivery of a valid signed and dated Standard Moorage Agreement.
- 2) The Applicant will contacted if and when moorage becomes available. The offer must be accepted within 48 hours, by completing the Standard Moorage Agreement. The first offer of moorage may be declined. **Maple Bay Marina must be notified of an intention to decline to remain on the waitlist.** In the event that the first moorage offer is declined, the Applicant will be contacted when the next moorage slip becomes available. If the second offer is declined, the waitlist deposit will be forfeited. Waitlist status may be reinstated for an additional nonrefundable deposit of \$50.00.
- 3) **Failure to provide accurate physical LOA may result in a substitution or withdrawal of an offer of moorage, and forfeiture of waitlist deposit.**
- 4) At no time is moorage assured or guaranteed. If no moorage offer is made within one year, the Applicant may apply for a refund of the administration fee.
